Thank you for providing the exhibit. Please add these items and resubmit:

1. The current arterial alignment as shown on the LRTP with 136' ROW
2. The proposed arterial alignment with 136' ROW
3. Visible aerial imagery
4. Floodplain location and limits
5. Show how the proposed alignment ties back into the conceptual alignment to the north and south of the proposed alignment change
6. Horizontal alignment information (tangent and curve data) for the arterial roadway, meeting a 45 MPH design.
  - a. Minimum horizontal curve radius of 1080'
  - b. 200' tangent lengths separating horizontal curves

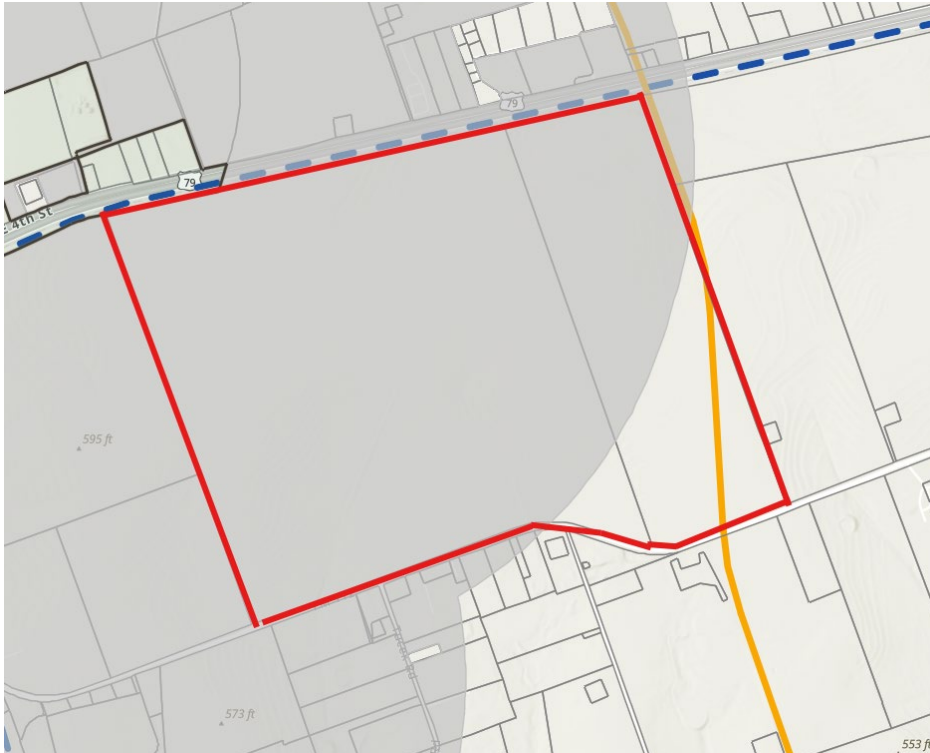
I have two questions:

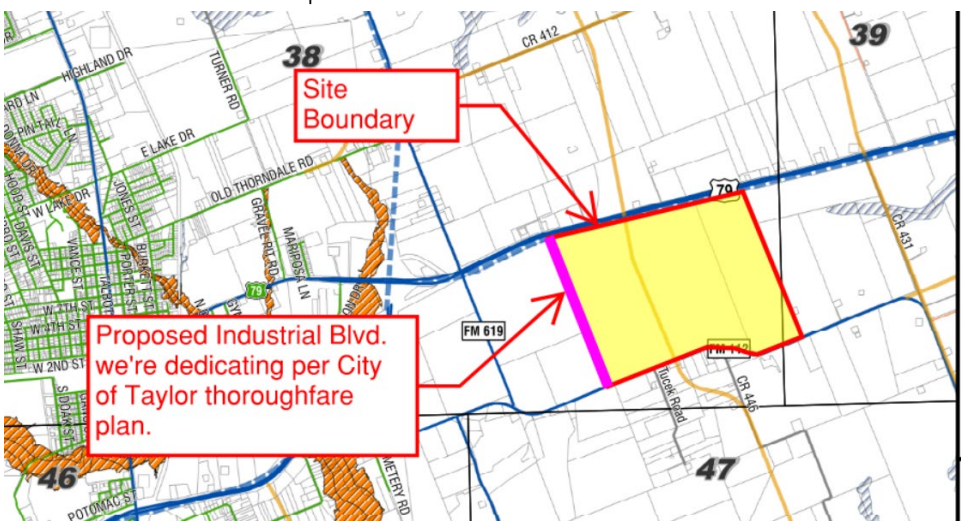
coordinating with the correct planning documents before submitting to the City this Friday.
